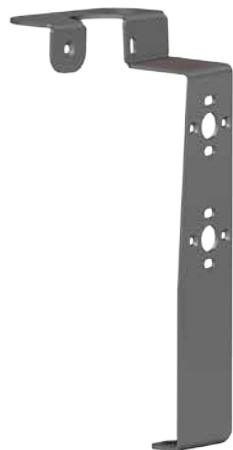

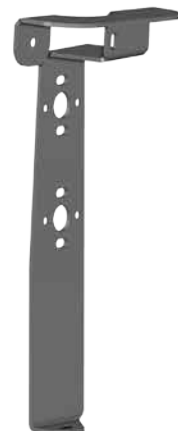
Left Bracket



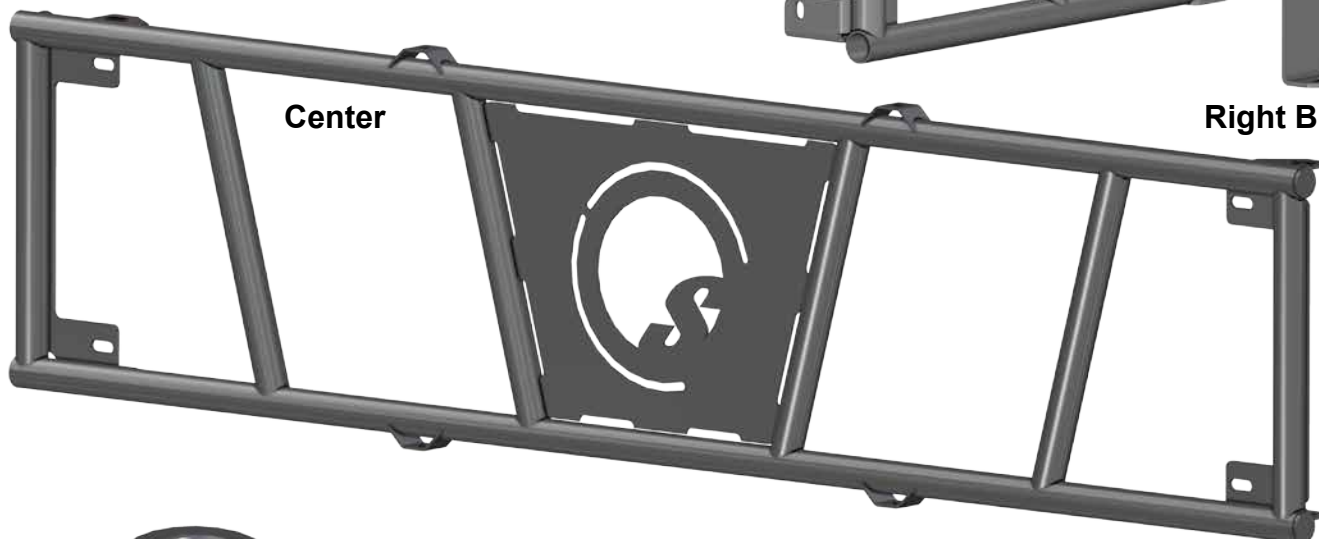
Left Side

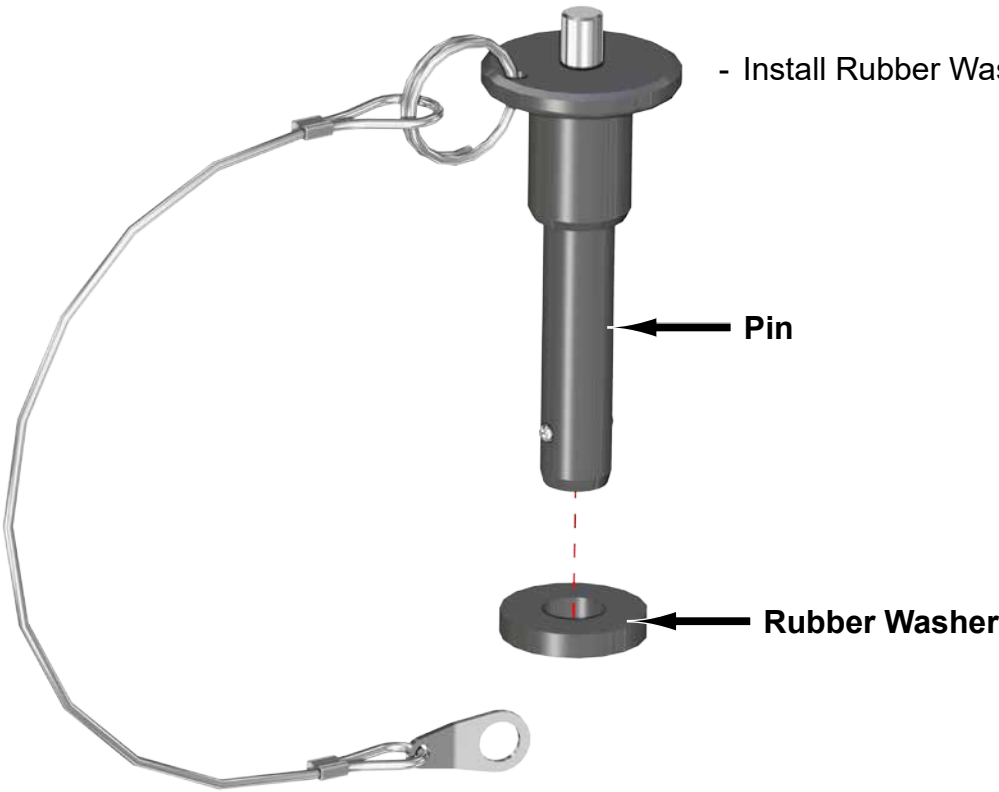

- Install Bumpers to Center with hardware shown; tighten completely.

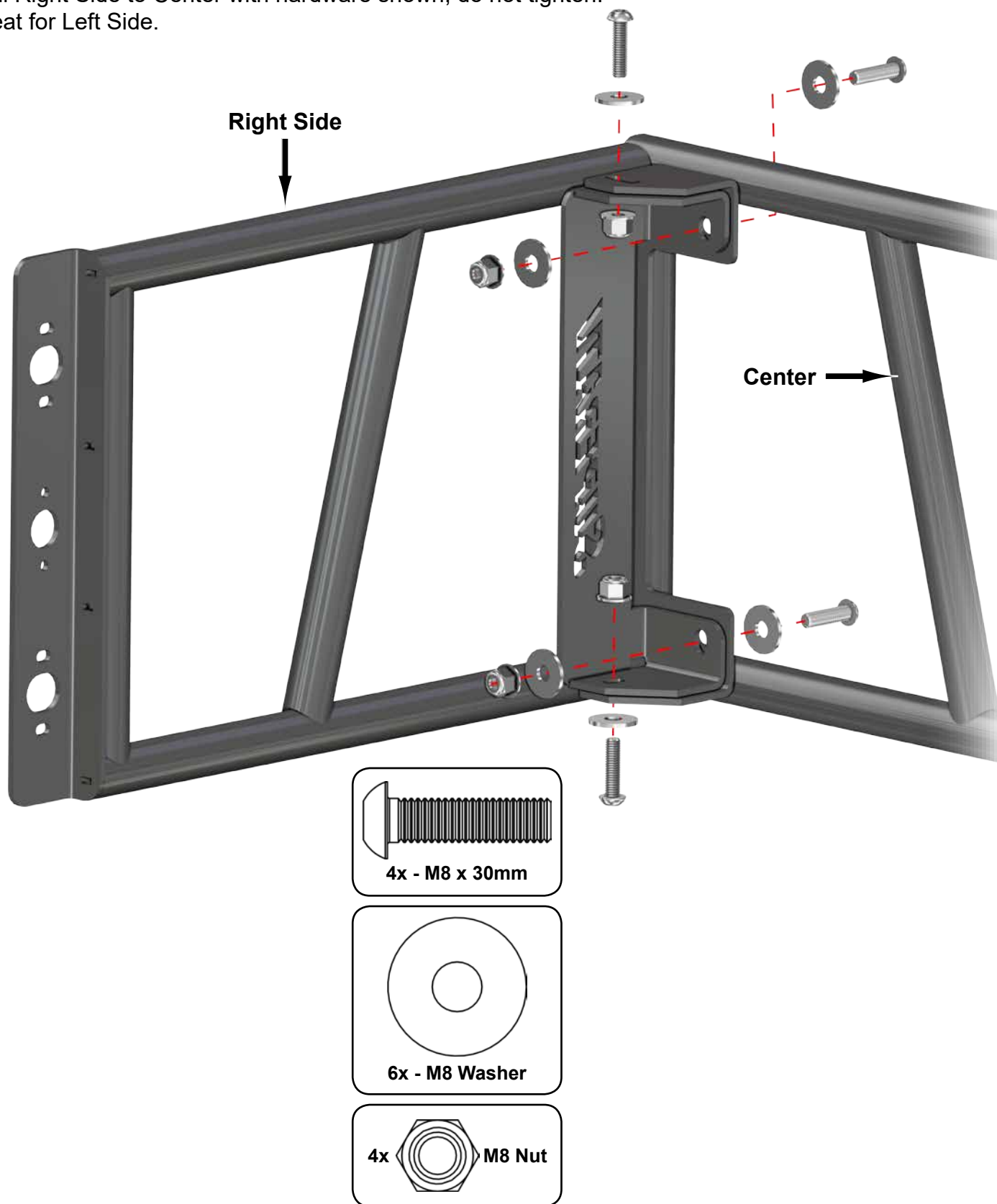


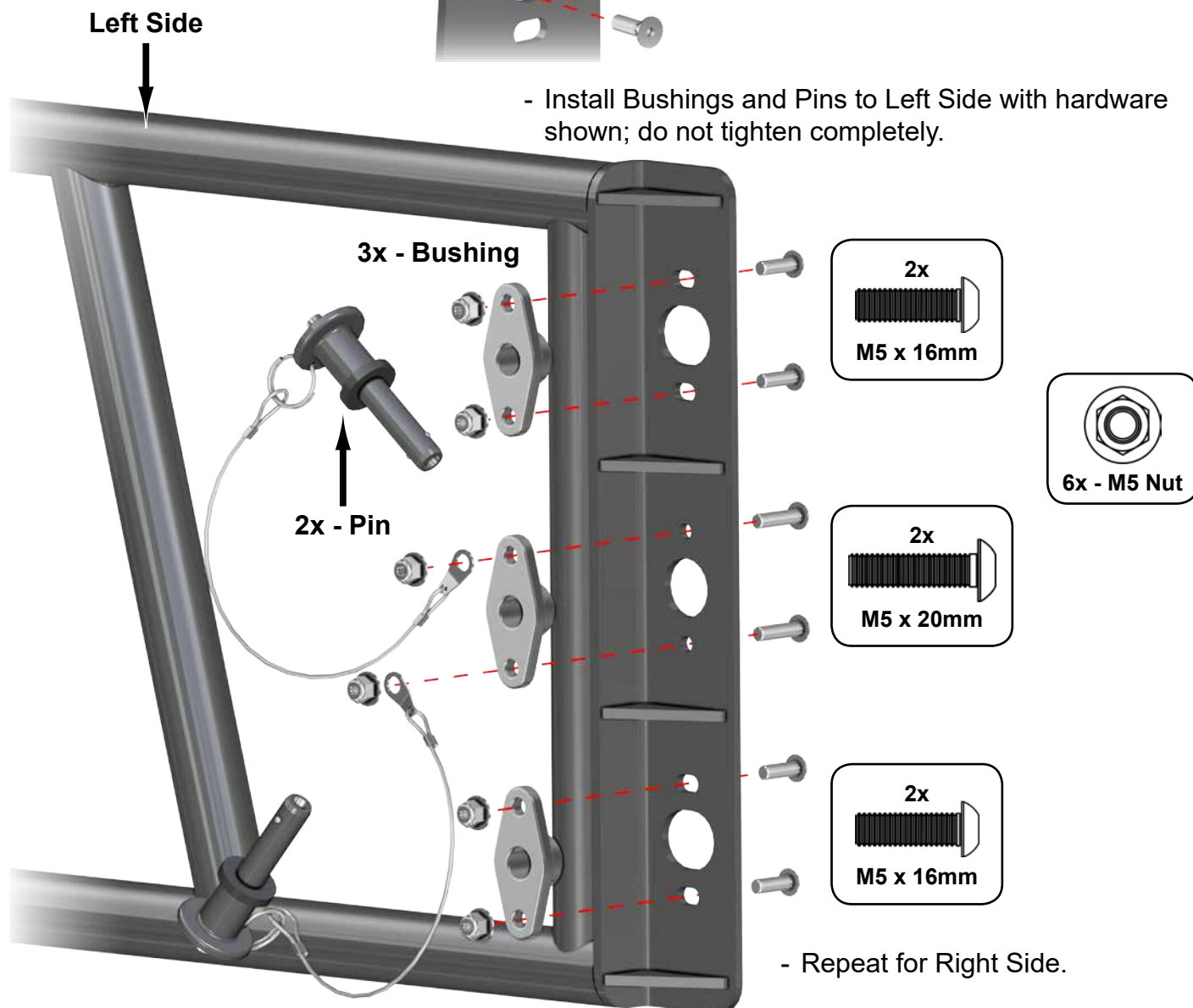
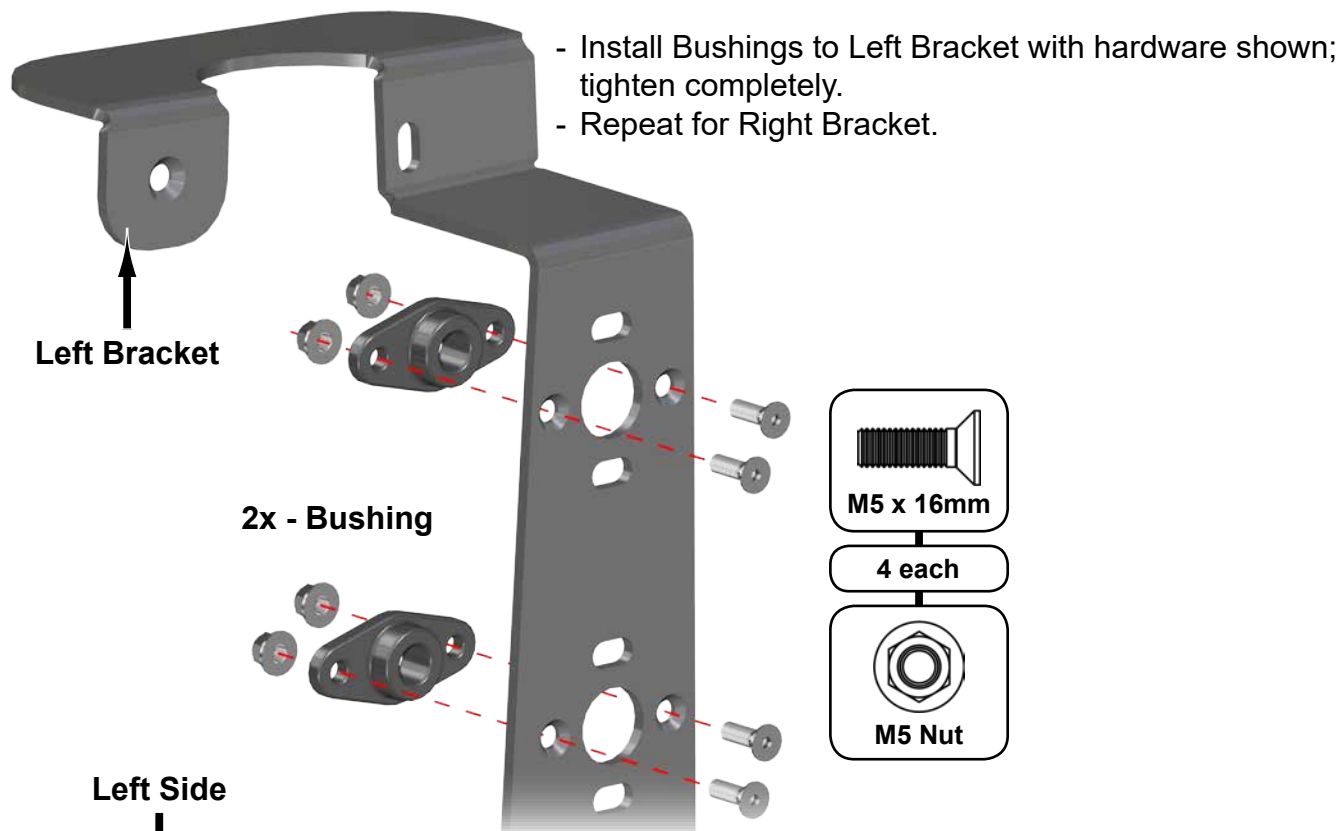
- Install Rubber Washers onto Pins.

- Install Right Side to Center with hardware shown; do not tighten.
- Repeat for Left Side.







- Install Left Bracket with hardware shown; tighten completely.
- Repeat for Right Bracket.





- Install Bed Extender.
- Insert Pins into Brackets in locations shown.
- Ensure that Bumpers are firmly in contact with Bed.
- Tighten all hardware.



- Remove top Pins and flip Bed Extender into Cargo Bed.
- Insert Pins into Brackets in locations shown.
- Ensure that Bumpers are firmly in contact with Bed.
