- Bag may be secured with Snaps only, Hook and Loop Fastener only, or a combination of Snaps and Hook and Loop Fastener.

- Determine where Bag will be located and firmly press Bag / Snaps assembly into plastic.



- Remove Snaps from Bag.
- Locate newly made indentions and screw Snaps into plastic.



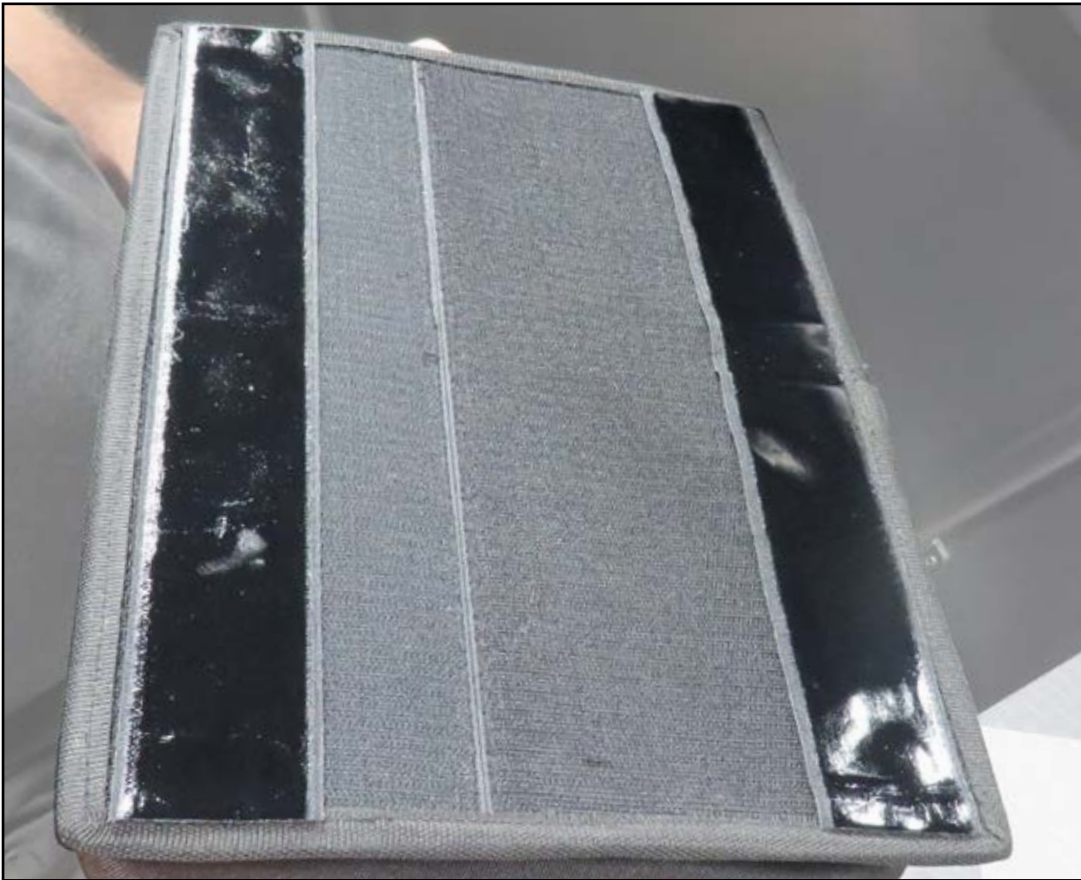
- Secure Bag to Snaps.
