



INSTALLATION INSTRUCTIONS





- Install Foam to inside of Lower Mount.




- Install Foam across top of Cage in location shown.



- Install Lower Mount to Dash and Cage with hardware shown; tighten hardware.




- Install Clamps to Upper Mount with hardware shown.
- Do not tighten.




- Place Upper Mount onto Cage. Top of Upper Mount should be against machines Frame.




- Secure Clamps around Cage; tighten hardware.





- Use hole in Upper Mount as a guide and drill through machine Frame. Hole should be large enough for a $\varnothing 6\text{mm}$ bolt.




- Secure Upper Mount to Frame with hardware shown; tighten.




- Install each Latch to Upper Mount.



- Install Foam to Upper Mount. Foam to run entire width of Upper Mount.










- Install Bumpers and Straps to Hood Mount; tighten hardware.


- Install Hood Mount with hardware shown; tighten.



- Install Bulb Seal to Windshield in location shown.
- Repeat for opposite end of Windshield.




- Install Windshield to Hinges on Lower Mount. Tighten hardware.



Separate components shown from Wiper and assemble to Windshield.

- Install D-Seal to Lower Mount in location shown.



- When Windshield is in open position, secure with Straps as shown.
