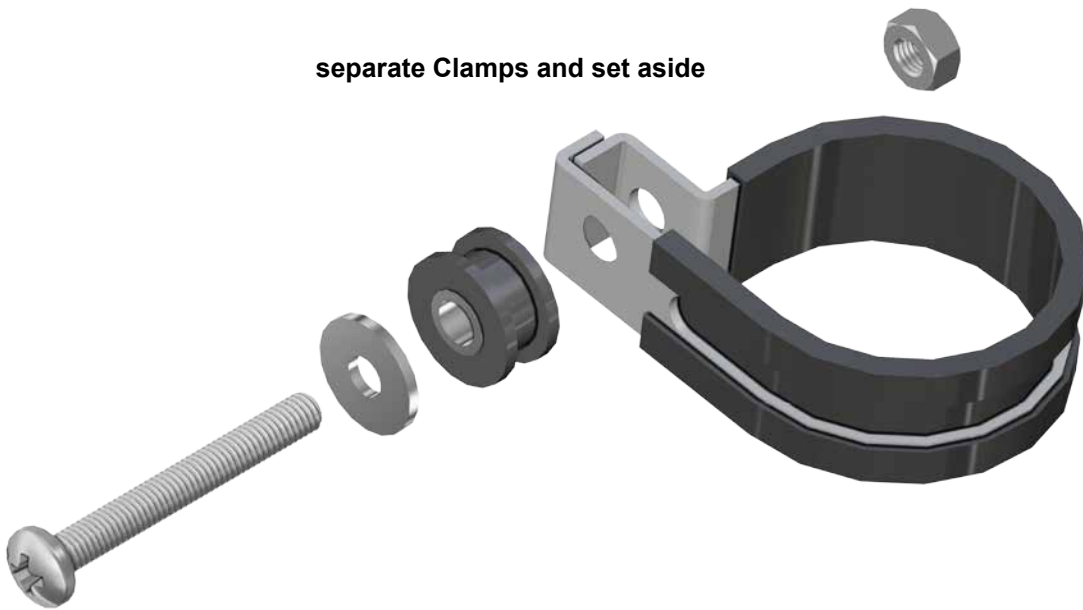

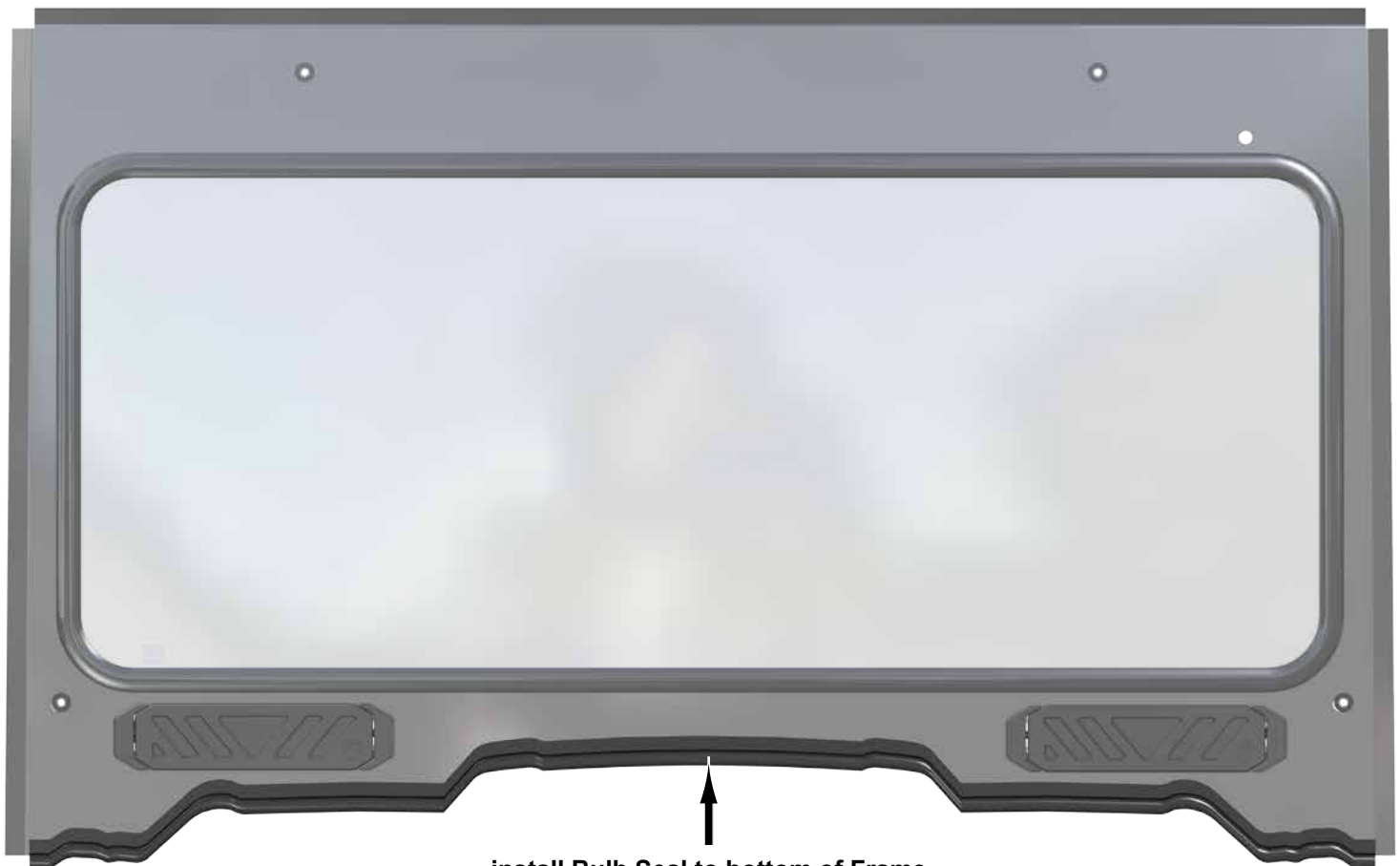
separate Clamps and set aside



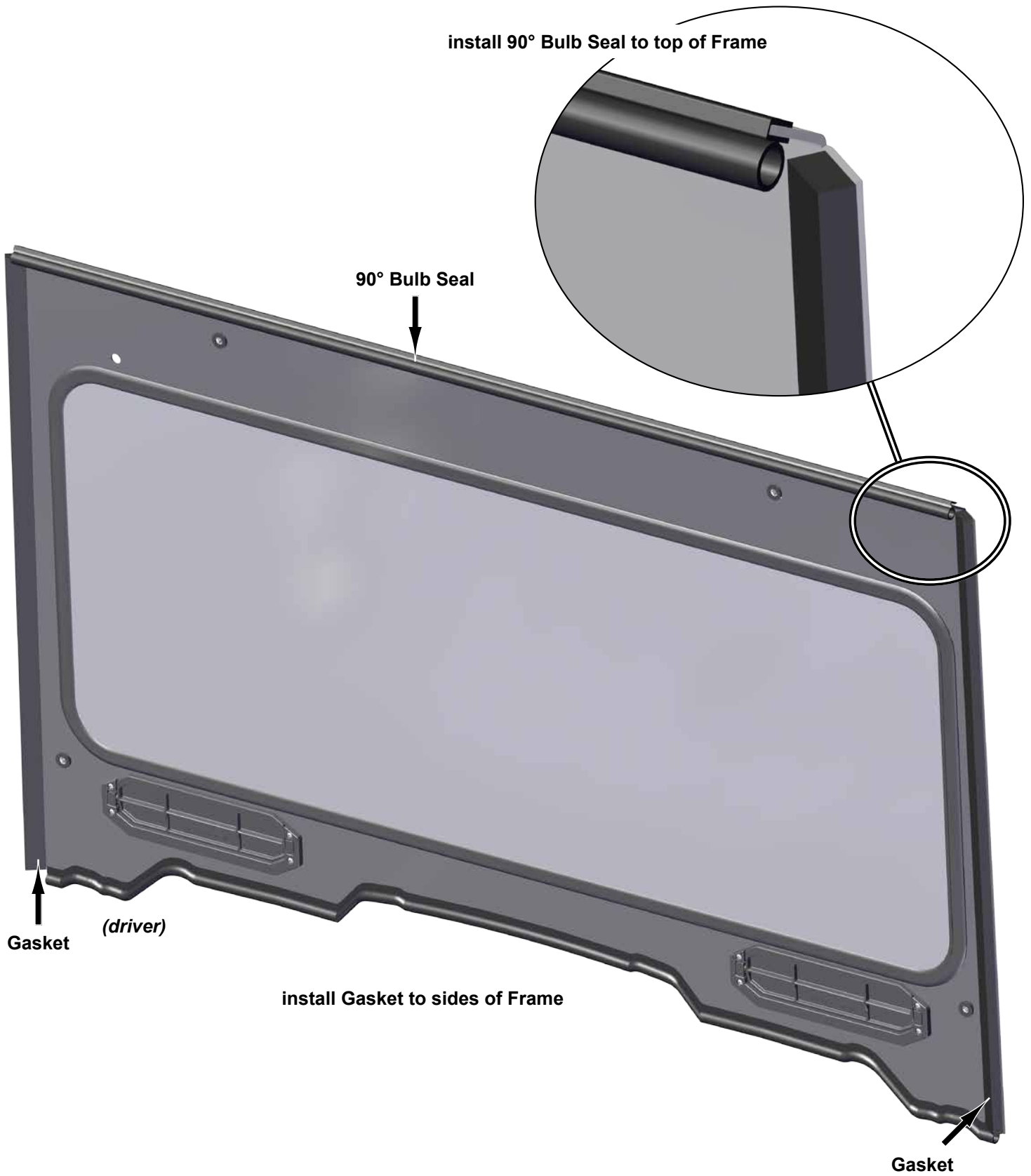
install Grommets, from Clamps, into Frame



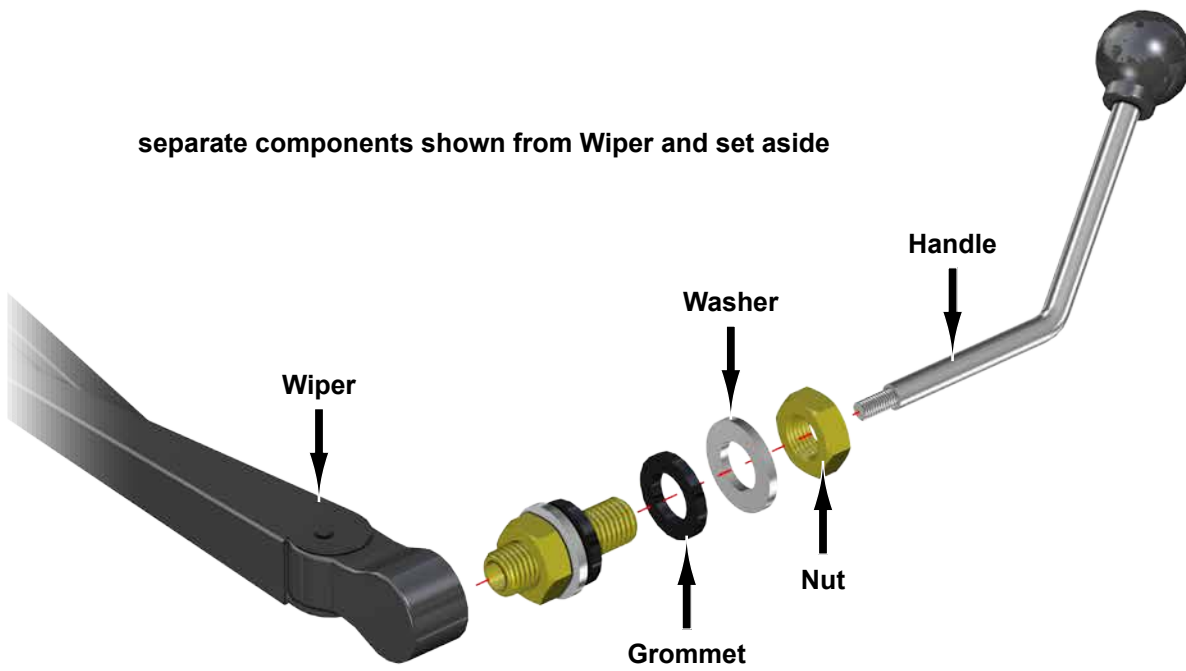
4x - Grommet



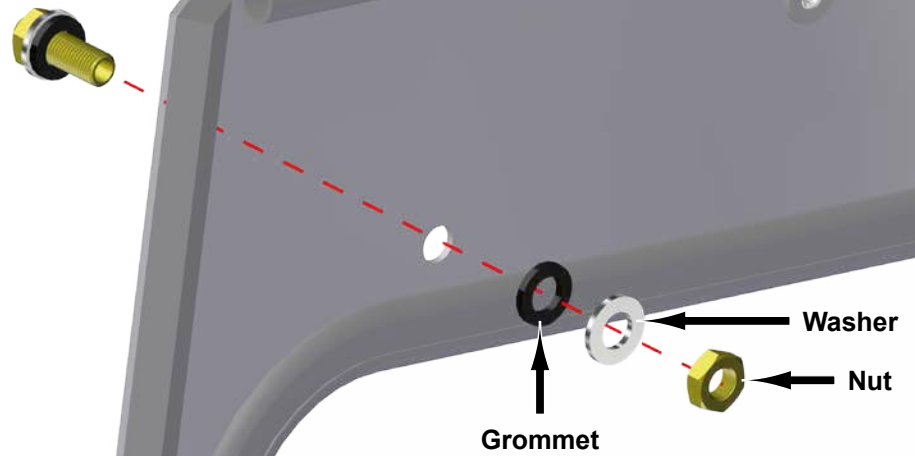
install Bulb Seal to bottom of Frame



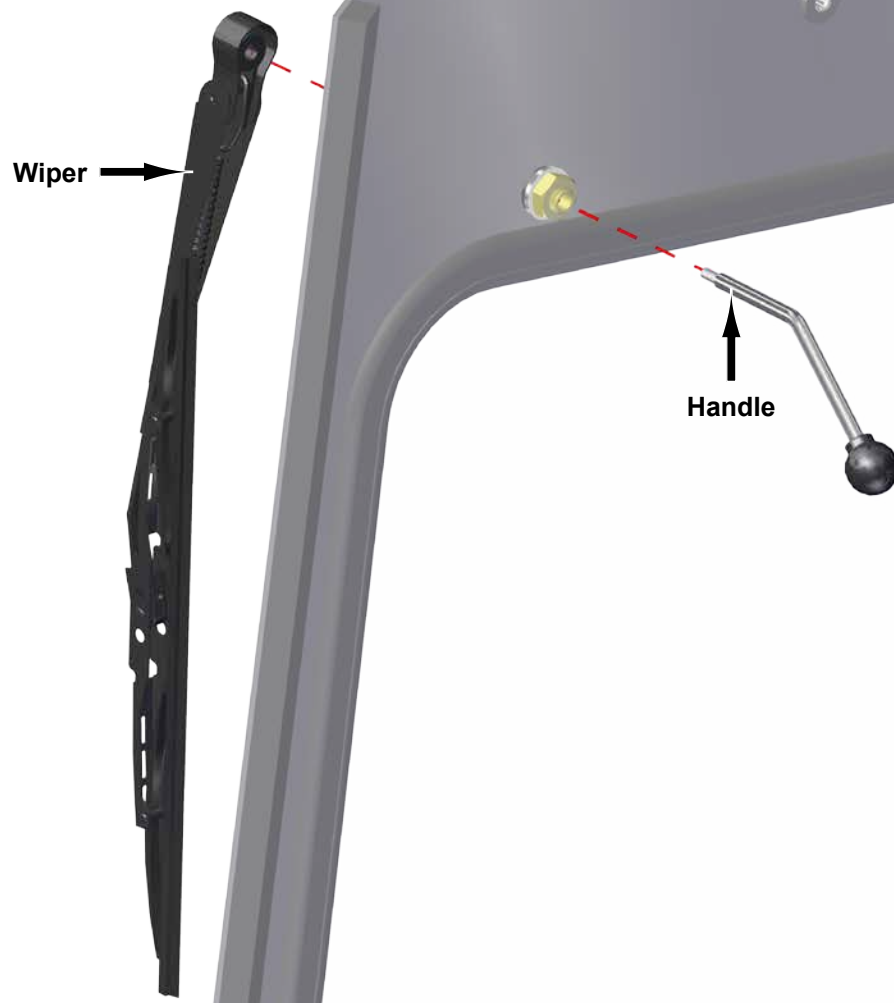
separate components shown from Wiper and set aside

install Wiper and Handle; do not tighten completely



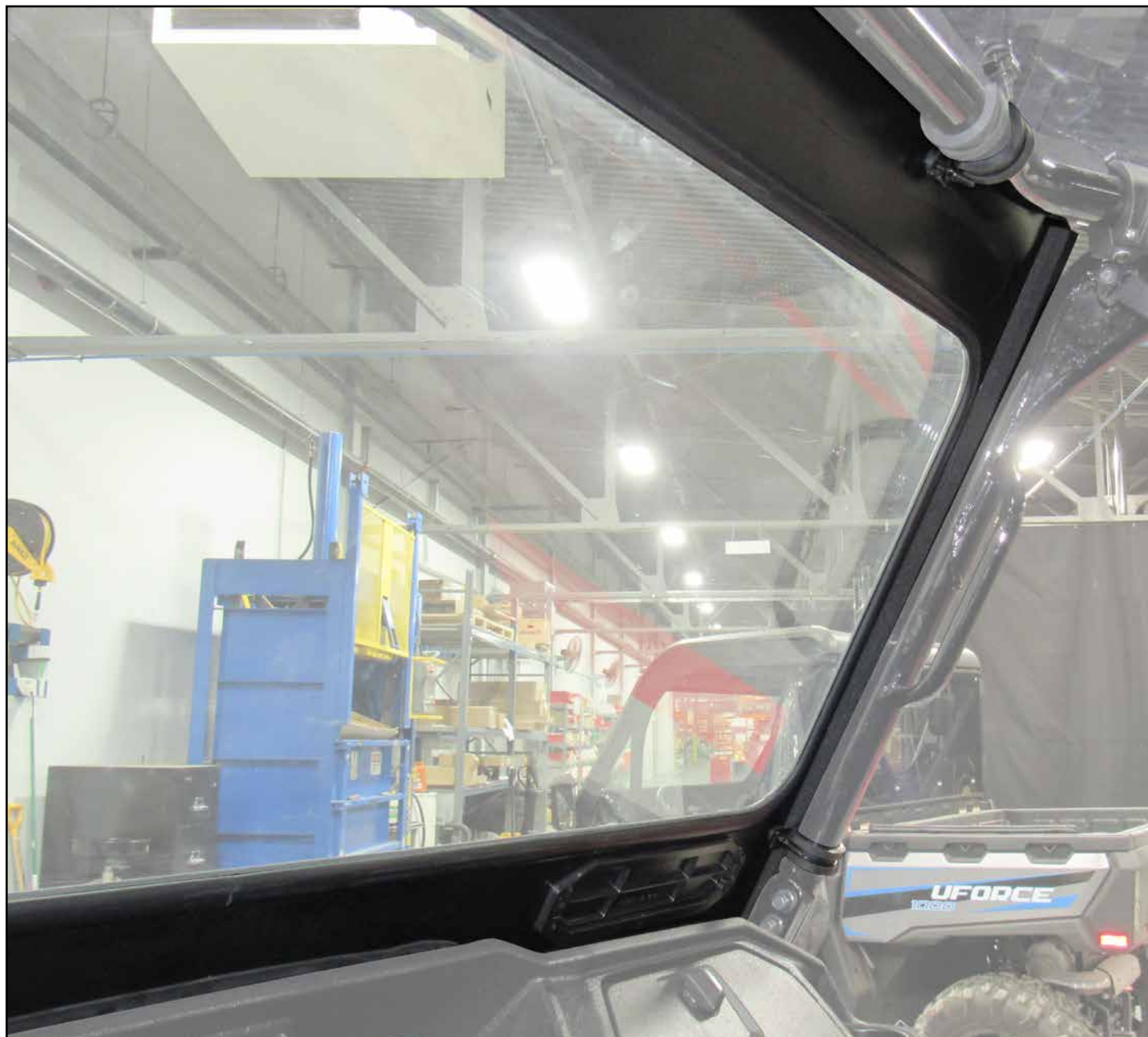
OEM Roof notes:

- Leave OEM Roof in place.
- Push Windshield up and under OEM Roof; some force will be required.
- SuperATV recommends an extra set of hands when installing.

place Glass Windshield onto machine



- secure Full Glass Windshield with Clamps and previously removed Clamp hardware
- tighten top Windshield Clamps before Roof Clamps



SuperATV recommends positioning Handle and Wiper as shown; tighten completely
